OBJECTIVES

4. GENERAL

Smoking is prohibited throughout the entire workplace with no exemptions. However, an area will be provided externally (employees will be made aware of it) for those who wish to smoke. The following responsibilities have been placed on employees and employer regarding this matter.

4.1 EMPLOYER RESPONSIBILITIES

- Designate a smoking Area
- Investigate complaints regarding employees, customers and visitors smoking and they must inform, consult and train employees on this policy.
- Ensure employees comply to the policy.

4.2 EMPLOYEE RESPONSIBILITES

- Ensure that they and /or others do not interfere with smoking area.
- Ensure customers and visitors are made aware of this policy;
- Know that no additional time will be given to employees who smoke;
- Inform customers and visitors of the correct smoking area upon arrival on site.
- Ensure smoking is done at the designated smoking area.
